Though focused on the procedure in the courts of England and Wales, the work also considers the jurisprudence of the many Commonwealth jurisdictions which have adopted the English procedure. A particular feature of the book is its analysis of the matters which are taken into account in the exercise of discretion, an aspect of the equitable jurisdiction applied to winding-up applications.
