Additionally, the book looks at how to attach debts by garnishee order or the appointment of a Receiver by way of equitable execution and explains the procedure up to the point of petitioning the High Court to have a person adjudicated a bankrupt. Finally, there is a discussion on Mareva Injunctions. The Practitioners Personal Insolvency Handbook contains an explanation of the steps required to obtain the individual orders and also contains various precedents of proceedings and necessary forms.
